Zwahlen et Mayr S.A.: Cancellation of Remaining Publicly Held Bearer Shares in Zwahlen et Mayr S.A. and Delisting Announcement concerning Determination of Last Trading Day and Delisting Date

Zwahlen et Mayr S.A. ("ZM", ticker symbol "ZWM" on SIX Swiss Exchange ("SIX")) refers to a decision by SIX Exchange Regulation AG ("SER") dated 17 December 2025. In this decision, SER approved the delisting of all bearer shares of ZM with a nominal value of CHF 200 each (the "ZM Bearer Shares"). The approval was granted subject to a final and binding cancellation judgement (*Kraftloserklärungsurteil*) pursuant to Art. 137 Financial Market Infrastructure Act ("FMIA"), the filing of the official notice concerning the delisting and the ad hoc announcement of the last trading day and the delisting date.

ZM announces today that the Civil Court of the Cantonal Tribunal of the Canton of Vaud has, by judgement of 26 May 2026 cancelled (*kraftlos erklärt*) all remaining publicly held ZM Bearer Shares. The judgment has become final and binding (*rechtskräftig*) as of 28 May 2026 and is published in the Swiss Official Gazette of Commerce (*Schweizerisches Handelsamtsblatt; SHAB*) by the Civil Court of the Cantonal Tribunal of the Canton of Vaud.

ZM further announces today that SER, in consultation with ZM, has determined with its decision by 15 June 2026 that the ZM Bearer Shares will be delisted on 29 June 2026, with the effective last trading day on SIX set for 23 June 2026 and the last technical trading day being on 26 June 2026.

As a result of the cancellation of the remaining publicly held ZM Bearer Shares by the Civil Court of the Cantonal Tribunal of the Canton of Vaud, each holder of cancelled ZM Bearer Shares is entitled to a compensation of CHF 147.10 in cash per cancelled ZM Bearer Share. The envisaged date for the payment of the compensation is 26 June 2026.

The trading of the ZM Bearer Shares on SIX will be suspended after close of trading on 23 June 2026 until 26 June 2026, the last technical trading day of the ZM Bearer Shares on SIX.
